I. Background

Tempe Parks and Recreation is conducting an equity study to analyze, assess, recommend, and act on equity within our parks and recreation spaces and programs. This study will build upon the guiding principles of the updated Parks and Recreation Master Plan, which was adopted in July 2021. The study includes a robust and embedded community engagement process, culminating in a comprehensive matrix that identifies and prioritizes gaps to ensure that future investment occurs in the areas where residents have fewer resources. It also establishes an innovative service philosophy that reflects a commitment to engage and serve all residents with boundless opportunity.

Two public meetings were held virtually on April 24 and a survey was available online at tempe.gov/Forum from April 24 through May 25, 2023 to gather feedback on the proposed concepts. This survey received a total of 641 visitors and 447 responses.

II. Outreach

Several methods were used to provide information to the public and stakeholders regarding the project, meetings and opportunities for input.

Outreach for the Parks and Recreation Equity Study was focused on obtaining input on social mixing, program diversity, feelings of safety, and access to amenities within the City of Tempe's Parks and Recreation system. The additional focus groups

outside of the Tempe Forum allowed for the direct input from the community to ensure park improvements meet the needs for all.

Direct Mailer

A direct mailer was sent to over 6,000 places of residence in very high equity zones and high equity zones throughout Tempe. In Making Space: Tempe Parks and Recreation Equity Analysis Memorandum, DesignWorkshop identifies equity zones by the layering and weighting of the following factors: Centers for Disease Control (CDC) Social Vulnerability Index (SVI) consisting of 16 socioeconomic factors, the CDC's Healthy Places data of asthma prevalence, mental health distress and physical inactivity, rental tenure, crime concentrations, and places of informal housing encampments, among others.

Yard Signs

45 yard signs with meeting and comment information were placed in various parks and community centers around the City of Tempe.

Emails

A notification email was sent to Tempe Forum subscribers, neighborhood contacts, relevant Boards and Commissions, parks update subscribers, Arts in the Parks subscribers and community partner stakeholders identified in the initial focus group outreach inviting them to attend the meetings or to comment online.

Making Space Festival

Hosted on May 10, 2023, from 5:30 to 7:30 pm at Escalante Park and Community Center, the Making Space Festival engaged community members with the Parks and Recreation Equity Study in a manner that was fun and free to all. Approximately 200

attendees enjoyed various activities including art, music, bike tune-ups, games, drop-in workouts, local food demonstrations, and tree and plant giveaways.

Virtual Meetings

Two [virtual meetings](#) were held via Zoom on Monday, April 24, 2023 to kickoff the public survey.

Community Navigator Program

Community Navigators were hired to assess parks and centers as well as assist with community outreach when the community survey was available. Community Navigators were a diverse group of community members who were each able to bring unique perspectives to this project.

Peer Solution Consulting

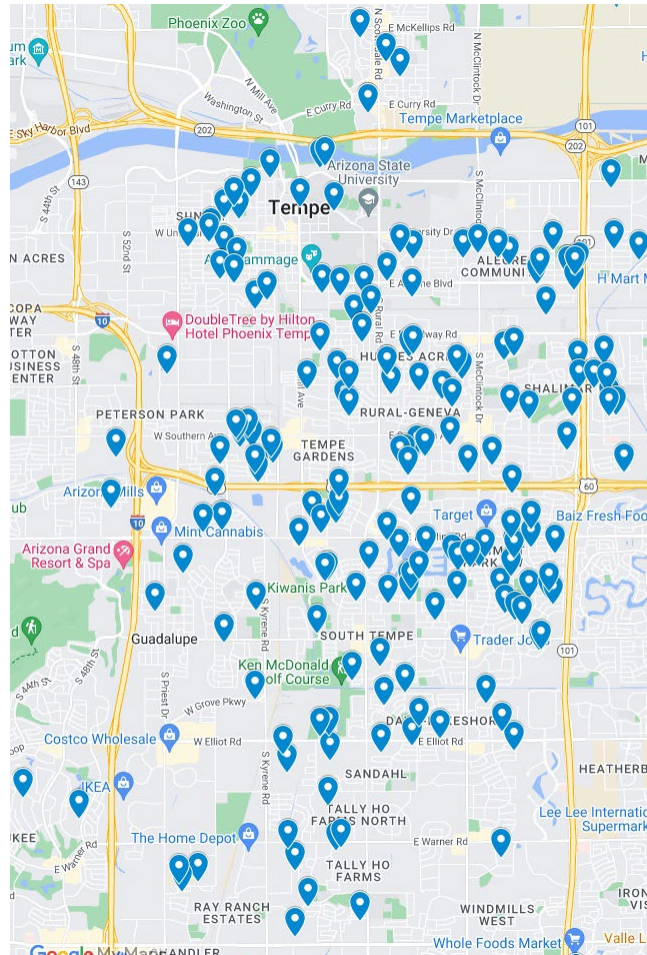
The local nonprofit, Peer Solutions, was hired to help gather feedback about Tempe's Parks and Recreation system from Tempe youth. The youth survey was designed to take approximately four minute to complete. Student who completed the survey were entered into a \$50 raffle.

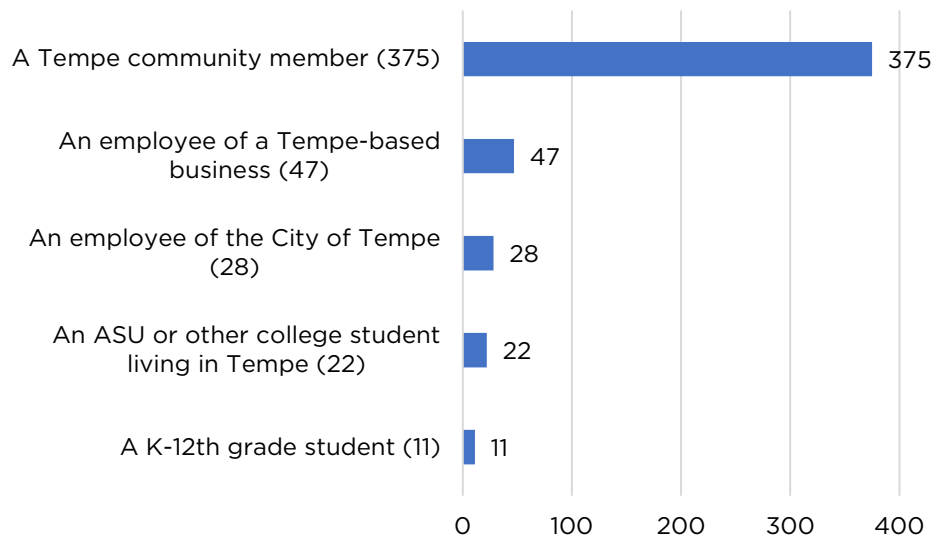
III. Survey Results

The survey was available online at tempe.gov/Forum from April 24 through May 25, 2023 to gather feedback on diversity, equity, and inclusion (DEI), program diversity, feelings of safety, and access to amenities within Tempe's Park and Recreation system.

209 respondents provided an address with approximately 85% in Tempe.

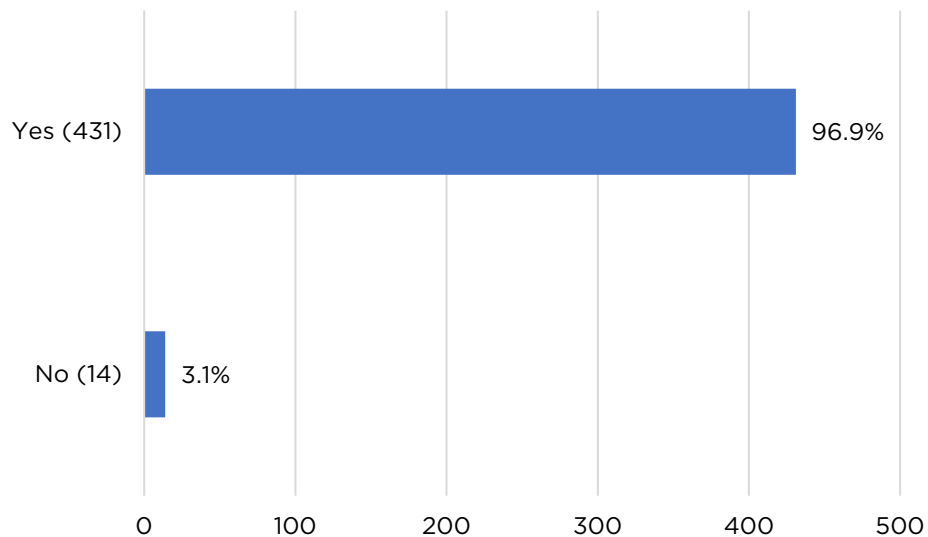


1. Hello, I am (select all that apply)?



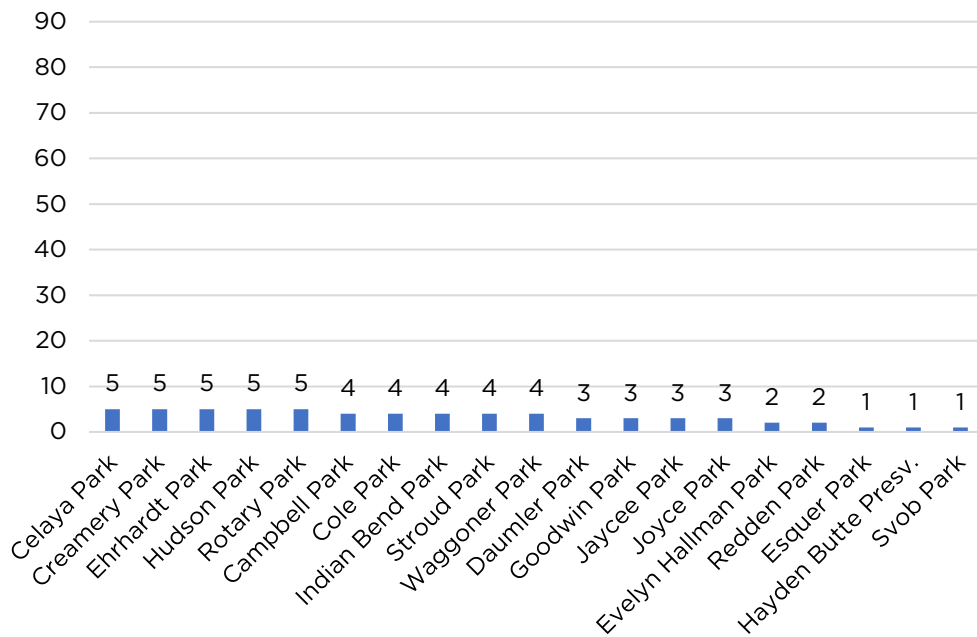
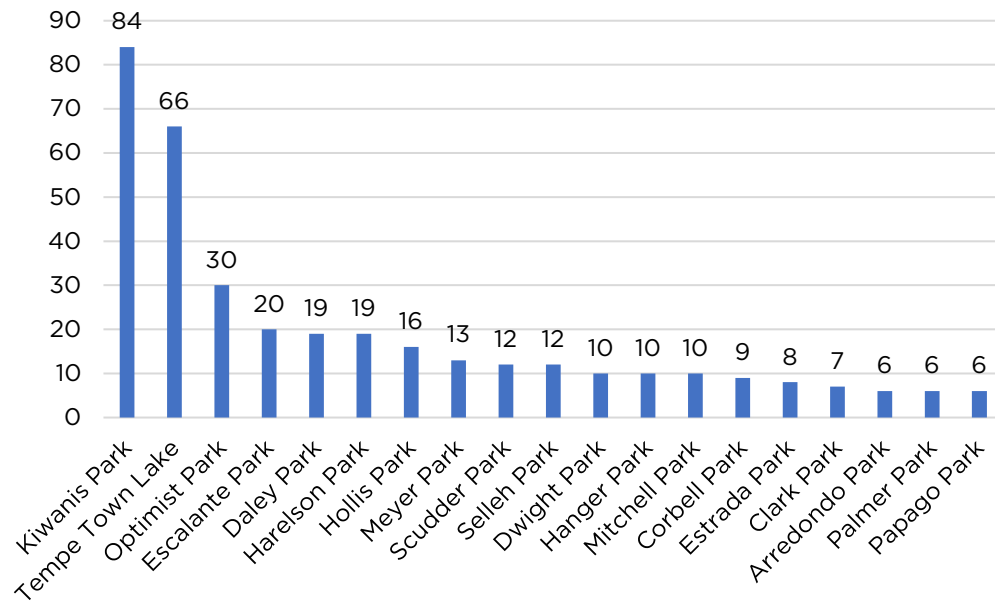

2. I visit City of Tempe parks



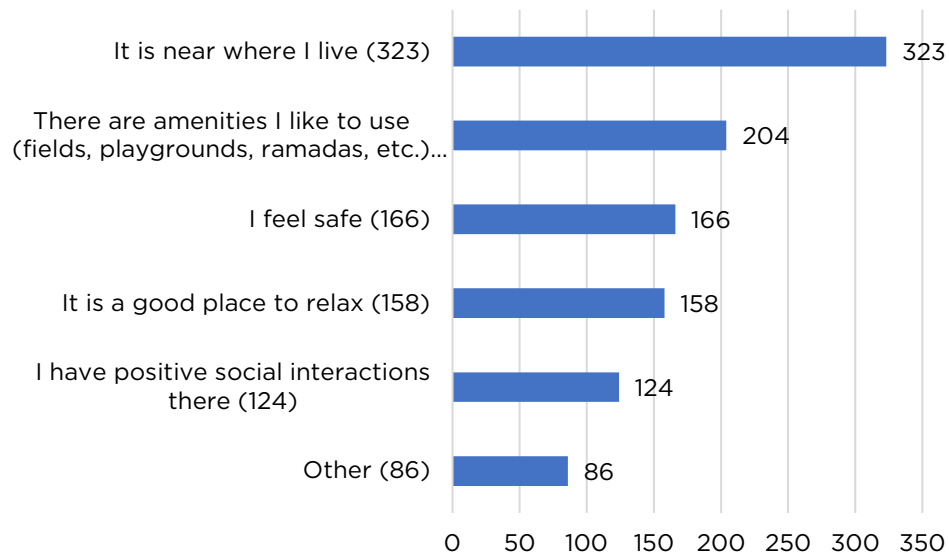
Responses: 445

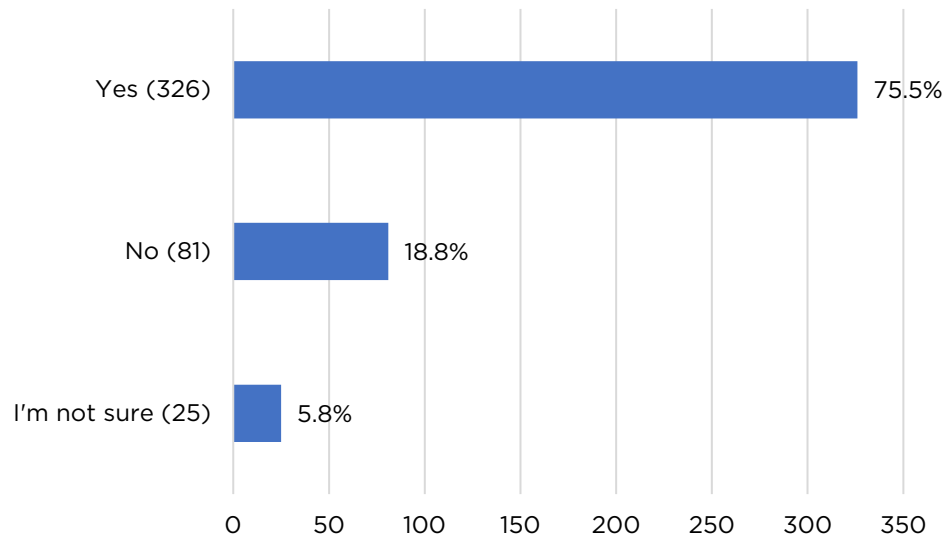

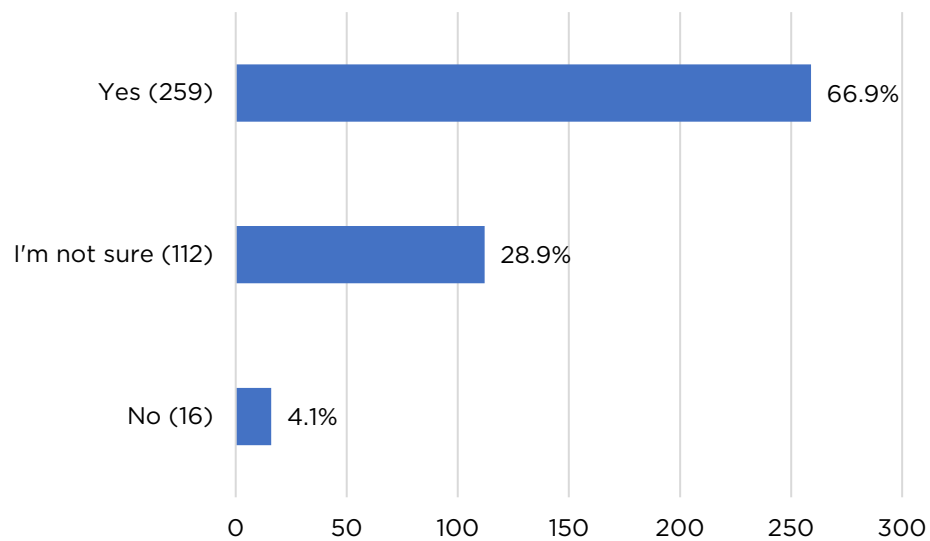

17. I am annoyed that this survey is more concerned about social buzzwords like diversity, equity and inclusion than generally improving parks and recreation opportunities for all Tempe residents. The more government tries to force these basic human decencies, the more divisive and exclusive people tend to become. Create more opportunities for all residents to enjoy, invite all to participate, and the diversity and inclusion will occur naturally. We need restrooms at the smaller parks no matter what race or economic status we are!
18. I am not a resident of Tempe but my daughter is (at ASU) and I have visited parks over the years and have had Coffee With Joel Navarro and the re-instated Police Chief during that time period where Police were being scrutinized. I am impressed with the dedication the City has toward all city services and your continued desire for achievements and improvement in all areas of city government.
19. I appreciate this survey, but fail to see the value in all the questions about equality, diversity. These parks are used by a vast array of people. Most of whom respect there availability. The parks employees seem to take a lot of pride in the condition of their park, thus many of the users are willing to help keep these parks free of litter and graffiti. It would be nice to have more restroom facilities in more strategic locations. The staff has a tough job to do in maintaining these parks, at times it seems they need more help.
20. I couldn't add this to the map but we need bike trails that are safe and have barriers from the street.
21. I enjoy all parks in Tempe
22. I feel the parks need better upkeep
23. I have spoken to staff attending events in Harelson Park and mentioned problems with Harleson and Hanger. There is a weed growing in the park that has small burrs with thorns attached. Spurge? I can no longer walk my dog in the park because he gets these in his paws and can no longer walk. Today, at the event in Harelson (May 3, 2023) a friend with two long hair dogs found more than 50 of these burrs on his dogs and they are very painful to remove.

Especially if stuck in his paws. It would be useful if your groundskeepers could identify these weeds and develop a means to remove them from the park.

24. I live in Chandler but at the border so parks closest to my house are in Tempe.
25. I really appreciate Tempe and this event
26. I really like when the community gets together and does arts, music and activities.
27. I support this survey, Thank You.
28. I think Tempe does a good job of providing park and rec. services. I don't think the police patrol Tempe Town Lake area enough at night on the south shore and there are several cars that race on the north side of the lake under Mill Ave bridge area.
29. I value parks and recreation for the overall quality of life enhancement.
30. I walk a large dog who has been attacked by off leash dogs. Even though my dog is trained at the Advanced Obedience level (off leash), I never have my dog off leash in Public because dogs are animals and therefore can be unpredictable. I do not use Dog Parks because people who do use Dog Parks do not always have their dogs under control. I have seen dog fights in Dog Parks and I do not want to risk my dog being injured. I see many off-leash dogs at Kiwanis Park (and other Parks in Scottsdale, Gilbert where we also walk). Off leash dogs make me feel very unsafe since my dog has been attacked and both of us were injured. Please enforce the Leash Law to keep everyone safe. Thank you.
31. I walk around Tempe town lake almost every day and would love to see some more amenities there, particularly water fountains (or better yet kiosks with more drinks and snacks) and restrooms. Would also love to add recycling bins to the lake area
32. I walk often with friends and we often aim for a park we haven't been to in awhile. We love the differences in the parks and generally think we have wonderful parks.
33. I would like more pickleball courts at Tempe Sports Complex. The existing courts are extremely busy during good weather, both in the morning and after work.
34. If Shalimar Golf Course goes away, please make it a park or something- not a high rise, apartments or anything else to increase population density, concrete, parking or more cars.
35. I'm a new "returning" resident to Tempe. In the past, I was highly involved in the community and have always participated in and want to continue participating in programs offered through the Parks and Rec program. I feel that there are less opportunities for people to participate in the community now than when I was a child or even my children were young. Having programs in central locations - isn't as helpful as having regular programs offered in the areas where people live.
36. Improvements to facilities should include on-site solar energy generation for all outside lighting
37. In the summer of 2022, I signed up my then four-year-old son to participate in the Shrimps swim lessons class at Kiwanis Pool for the full summer season. He had never attended swim lessons before. My son has an auditory processing disorder. You can educate yourself on those here:

<https://kidshealth.org/en/parents/central-auditory.html>. He can hear but his brain doesn't always make the typical connections for sounds. As a result, new sounds or loud places can be overwhelming. He can have a lot of anxiety in a new setting. This is typically expressed through tantrums or "koala-like" clinging behavior to me. When my son is comfortable, adults still often need to tap him on the back or shoulder, say his name, and make eye contact to help ensure comprehension. He also has difficulty speaking himself and sounds as though he has multiple speech impediments. He goes to full-time preschool, participates in team sports like soccer and t-ball and attends individual and group speech therapy. He responds well to his instructors there, has lots of good friends, and loves to learn. Here is what I observed during his first and only swim lesson: I saw my son in a brand new, very loud place: Kiwanis Pool. I saw and heard him express his anxiety. I spoke briefly with his instructor about his disability and suggested simple re-direction if he isn't paying attention or tapping him on the shoulder if it doesn't seem like he understood instructions. I saw an instructor very sweetly offer my son a toy frog to help him feel more comfortable. This worked beautifully and I saw him warm up enough to sit with his new teacher and classmates. He did not get upset. He did not cry. He did not refuse to let go of me. In fact, when it was his turn, I heard him his instructor if he could go in the water now. I saw him doing a happy dance of excitement as he entered the water. I heard him yell that this pool is just like the beach, which he loves. After that, I never saw a smile leave his face. I saw him start to wander off from time to time, but I saw him respond to the instructors' re-direction. I saw other children in need of occasional re-direction as well, including a boy who continuously splashed the instructor in the face and a girl who began to cry when she needed to use the restroom. I saw my son try new things. I saw him put his face in the water, which he will never do for me. I saw him use a kickboard. I heard him yell back to me "Mama, look, I did it!" At the end of class, he rushed to me, and I could see the pride and joy in his face and it matched my own. Unfortunately, Kiwanis Pool management saw something different. At least, I assume it was management. A young man came up to me as I was helping my son was dry off. He did not introduce himself to me, did not give me his title, nor did he ask my name. I run a cultural institution in downtown Phoenix with over 100,000 visitors a year - this is a failure of customer service 101. The man expressed that there were clearly some "serious behavior issues" displayed by my son today. He went on to say that "we can't have children just swimming off like that," as though my son was being willfully disobedient. He can't have his guards just watching one child. He then went on to inform me that if my son didn't "behave" better next time, we would be asked to leave the class. Stunned, I stated that my son has a disability and this was not misbehavior on his part. I saw the young man's face freeze as if he was not expecting this response. Another person (again, I'm assuming a manager but this person also did not introduce themselves or ask me my name) blithely suggested things would be better next week. I rushed my son to the exit to leave. As I left, I did not see management approach any other parents, including the boy who kept splashing the instructors and the girl who actually did have an emotional outburst. I withdrew my son (and neurotypical daughter) from swim lessons the next day and have not even looked at a City of Tempe recreation brochure

since. I wish I had said more in that moment. I wish Kiwanis staff had approached me in a different way. Based on this interaction, I am left to believe that Kiwanis Pool staff (and possibly other Tempe Recreation staff) have never come across a neurodivergent child before and have no idea how to work with this audience. If there had been even a moment where I felt a sense of community or collaboration, that the pool management was at all invested in setting up my son for success, we would have come back. But this interaction left such a horrible taste in my mouth. Your managers reduced a true moment of happiness and accomplishment for my son into a ""bad behavior issue."" I saw my son being brave and happy. Your staff saw a problem to be solved. I sent this story via email to the Kiwanis Pool management in June 2022, and requested a full refund for the summer from the city, which I received. I never heard from any City of Tempe staff regarding my experience - I only saw proof of the refund in my bank statement. City of Tempe recreation employees need basic customer service training, basic pedagogical training for interacting with young children, and training on how to create an inclusive environment.

38. Include better (yet inobtrusive) signage pointing out where to find certain ramadas, the two playgrounds, where pickle ball courts would be if you add them, etc.
39. I've written to our newest city council members and I'm disappointed that they don't even verify they received emails. I hear this from my neighbors as well. I voted for most of them, but they are not listening to their constituents.
40. Keep up the good work! This survey is a great idea to see where the city can make improvements. I would love to take my mother to my neighborhood park but it would be hard for her to walk in the grass. She broke her hip last year and needs a flat surface like a sidewalk to walk on. It would be great if more parks had sidewalks all around them. Also, more shade trees or shade areas with benches and sitting areas (these would need to have backs and some type of armrest so she could get up from a sitting position). Maybe check in with the Disability Commission for inclusion ideas for parks? Or the ADA guidelines? We have a great city but could do more!
41. Lack of maintenance in Tempe Parks is causing long term damage that will cost more in the future to repair. Weeds are not pulled, trash is not picked up, land scaping is not maintained and infrastructure is not maintained. Water erosion is causing damage to park structures because weeds are not pulled from cracks in the side walks and landscaping trash is not picked up and causing collection of water. The management of the City of Tempe should be ashamed of the condition of our City parks. Do not blame the homeless because maintenance is not being performed as required.
42. Let's get over this DEI. We do not need any more decisiveness. We live in USA and English is primary language. I am impressed in Kiwanis park staff workers.
43. Love Kiwanis park the most
44. More shade. Prioritizing native plants over non-native plants. Large attractive (art opportunity here) murals or signs that encourage recycling and throwing trash away in the proper place as many of the parks are littered as park-goers are careless. Creating a community culture that encourages recycling in an artistic way would go a long way. Kids in Tempe are simply not taught enough about recycling.

47. No on the new sports complex - we need to spend money on fixing streets and improving the quality of life for neighborhoods reducing the need to drive. The new arena will disrupt our tax dollars and lower property value.
48. Other: housing unsheltered
49. Overall, I love Tempe Parks & Rec. The programming and opportunities for community learning & enjoyment are fantastic. All parks are well maintained and it is easy to log in online to the app to report issues, like too many ants at the playground or feeling unsafe due to the presence of vagrants engaging in inappropriate activities & they are responded to very quickly. My only complaint is access to a bathroom at certain park areas. We live close to 2 parks that are across the road from each other & separated by an elementary school. However, there are NO toilets at either, and the school does not have open facilities. While I understand the safety & extra-responsibility & maintenance they are, it is a hassle for kids (& older adults) with smaller bladders to have to leave to go home to pee. It usually means we leave & don't go back that day & playtime is forced to end early. Also, little boys will water the trees & bushes, which probably isn't the healthiest option for the park or the visitors.
50. Parks here are great overall! Services should be expanded to cover lower income communities who may not have a car, as well as seniors and those who have physical difficulties accessing Parks.
51. Parks need to update facilities bathrooms and courts and ball fields. Pickleball courts in Daily Park is a great goal.
52. Paying for parking (e.g. Tempe Beach Park) is exclusionary. Tempe needs to follow Mesa's lead and keep parking free. Housing near our parks is so expensive, it is insulting to have to drive to a park and not be able to park. I do not care for parks as vehicles for building businesses/revenue for "entrepreneurs" or for tourists. It is vital that parks and access to them are free - for the children, the elderly, houseless people, everyone.

54. Please give thought to following Phoenix Parks and Recreation by making all P&R smoke and vape-free, including parking lots. Let me know if you'd like to see the sign that Phoenix P&R has developed to help educate about their new policy.
55. Please keep providing great amenities. The scariest part of the parks is the drug addicted population. I do not want needles in the grass.
56. Please make the sidewalks friendly to rollerbladers. Those decorative cement elements that are rough concrete are not good.
57. Providing excellent parks and quality programs will attract businesses which are forward thinking. Not GPLET!
58. Pyle Center could use an update. Expand programs to neighborhood strip mall leasing space. Walk and exercise programs in the neighborhood parks. 72. The city does a fantastic job with its parks, providing different amenities, & programming services! In terms of equity & inclusion, please continue: Collaboration on ground/staff level with TempeCares & training for addressing different populations: Parks are at the forefront of addressing unhoused populations & often get overlooked in their role across different cities. Ensuring staff training is provided to address different populations (i.e.. de-escalation, disability awareness, etc.) & that the city's Tempe HOPE/cares (& maybe PD) is engaged with programming & outreach is critical as it relates to safety concerns & overall accessibility to park services for community members. Parks are some of the few places people with limited resources can exist & relax & providing things like contact info. to promote awareness & facilitate city services for mental health & housing support can be helpful in

printed material on ramadas or at events. It may not be the responsibility to be a health care provider, but recognizing the role parks play in addressing mental & physical health means staying engaged/ connected to resource providers that do. Engaging at-risk Youth w/programming aid & resources: For usage of parks in underserved populations, connecting youth in outdoor activities and programming is key as parents may not be engaged, available, or aware of services, or those in LGBTQ+ communities may be needing the events & spaces Parks provide away from home. These populations may face cost issues for programming as well. Perhaps having staff for youth programs check in at basketball courts can help or having options for low-income aid. Diverse facilities & promoting healthy/active lifestyles to park users outside typical programming: Tempe does a great job at recognizing the amenity needs of young adults/aging adults. Dog parks are increasingly important, but so are passive walking & fitness trails. Especially for families of different cultural backgrounds, they may go to the park & not the rec. center to walk around to address their health; similarly, renting ramadas for birthdays may be the only point of contact with parks staff, so having dual language signage (QR code) to promote awareness of education & program availability is an idea. Walking trails w/fitness stations are an inexpensive way to help bridge the gap for health disparities for physical activity. Connecting health organizations & programs like ParkRx would be great when programming community events to facilitate active lifestyles (partnership with walk groups, diabetes prevention organizations, 5ks, etc.). I love the walkability integration in Tempe's parks with shaded paths & sitting areas. Similarly climbing or parkour areas for young adults is also great at addressing the need for physical activity & getting people out. Providing flexible field access to small informal groups like LARPing or Jugger can also address sports and populations that otherwise are not typically included or compete with bigger organized sports like rugby or soccer. Overall, I understand the costs of providing resources & the challenges in prevailing needs for tackling mental health & housing; However, to address equity and inclusion, the need for parks to be involved as a point of contact & facilitating communication is critical and should leverage every opportunity to collaborate with other city efforts & promote awareness of existing resources.

73. The City of Tempe has aging park infrastructure and a good plan in place to address and update our parks. However, no consideration is given to increased maintenance cost in both staffing and equipment.
74. The closest parks to my house have homeless people and trash. Kiwanis is only safe when it's very busy. I wouldn't walk around the lake at a quiet time of day. The splash pad has had homeless people bathing in it. Bathrooms are nasty.
75. The increase of Street People (the regulars that hangout and panhandle at the intersections and hole up in nearby neighborhoods) in Tempe is disturbing especially with all of the City of Tempe ""Homeless"" resources. It seems that it's actually attracting more destitute people to panhandle and carry on in the same manner as those who have been in there for YEARS panhandling. We do not let our girls ride their bikes to their schools or the parks because of all of the homeless/street people loitering around. WE FEEL UNSAFE in Tempe.

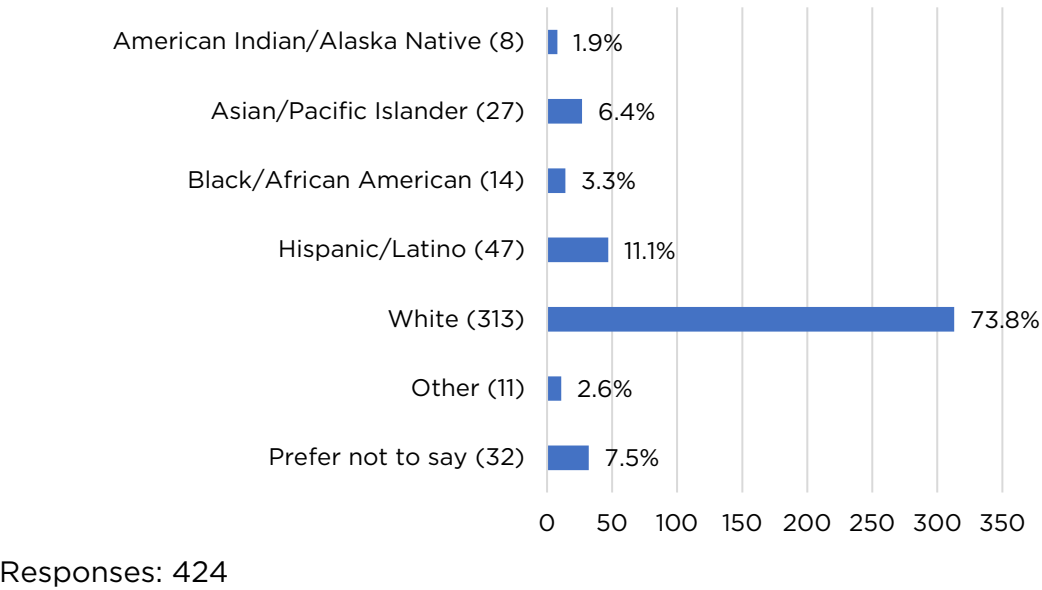

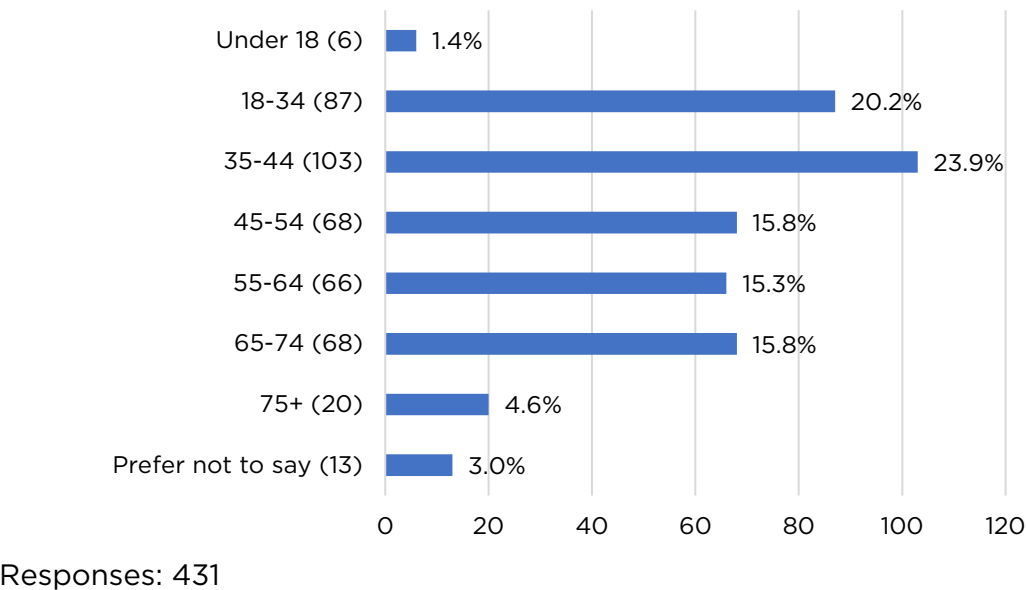
IV. Demographics

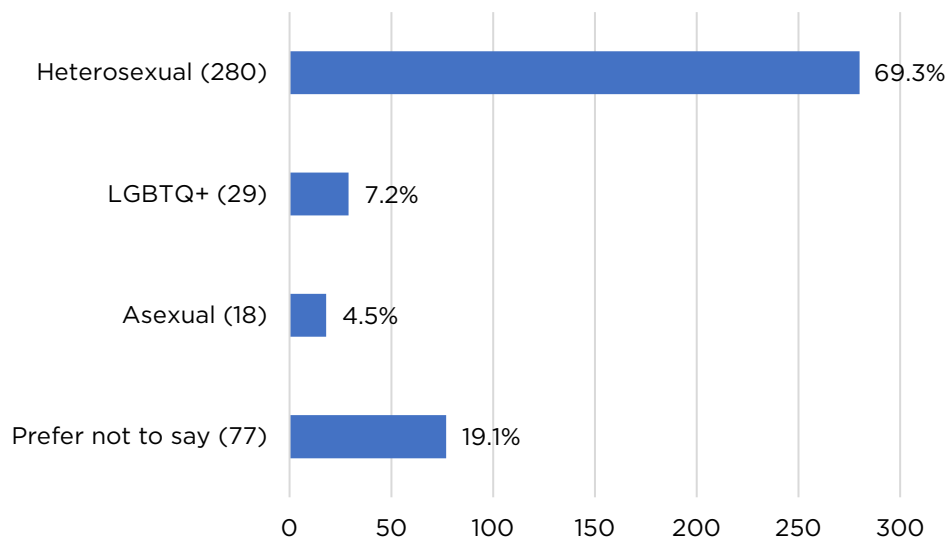

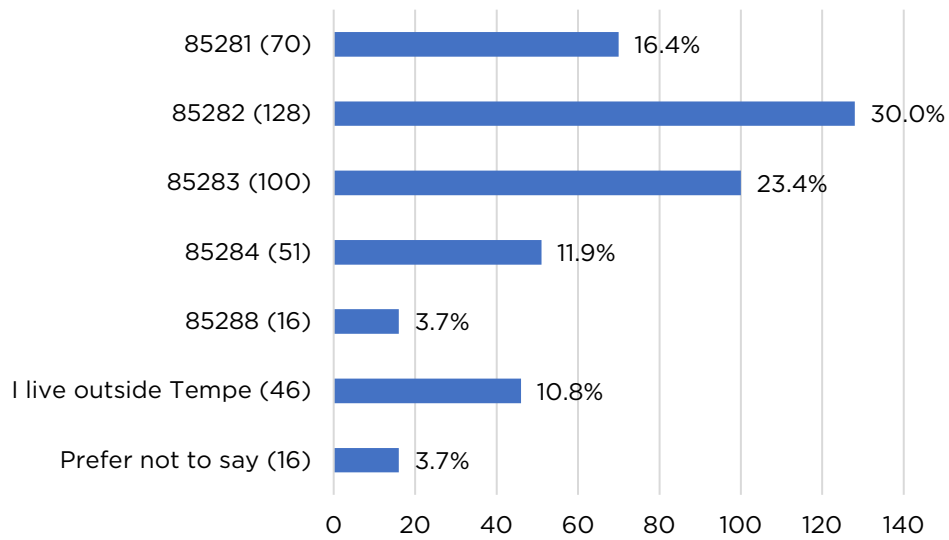

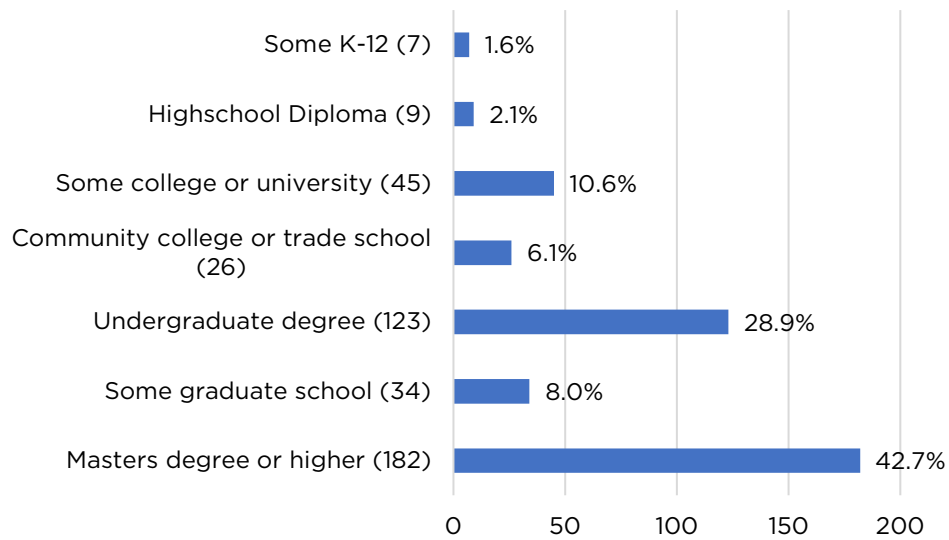

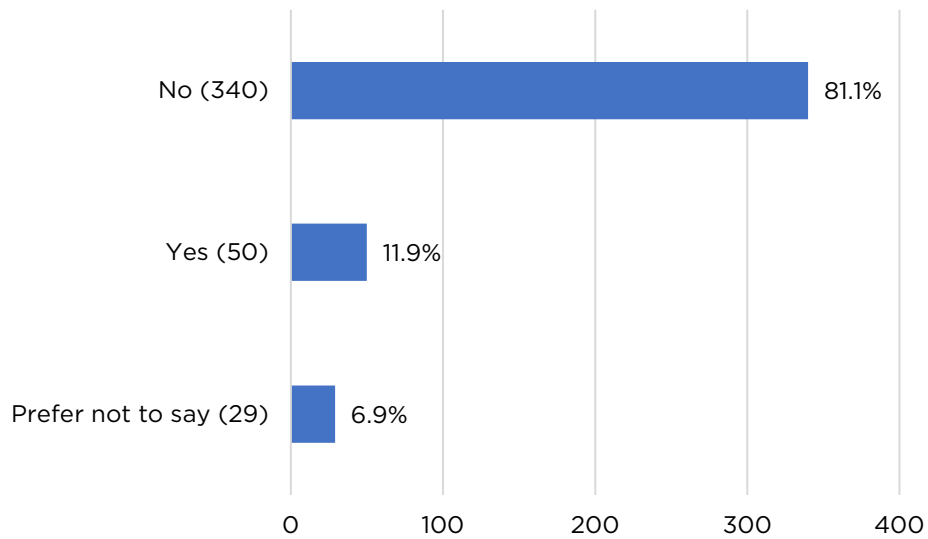

Highest level of education received:



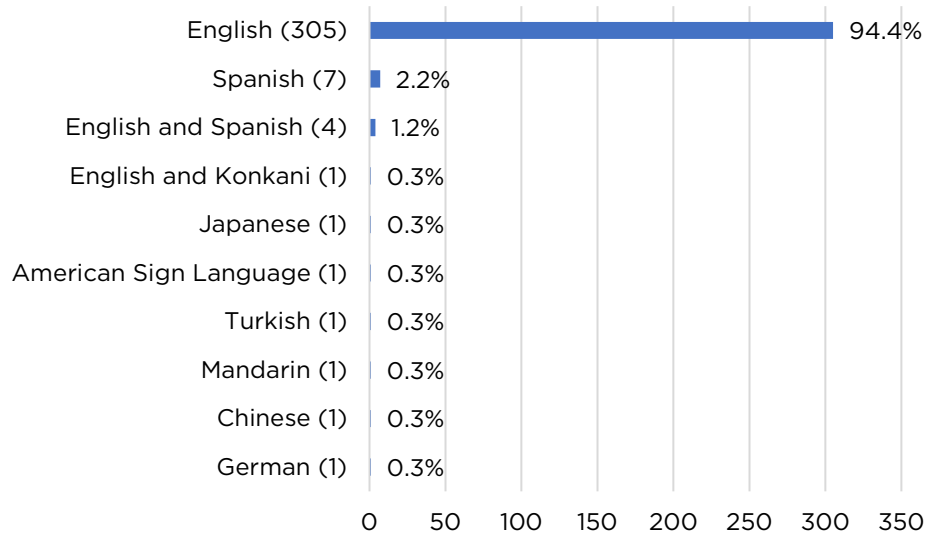

Do you have a limiting condition or ability?



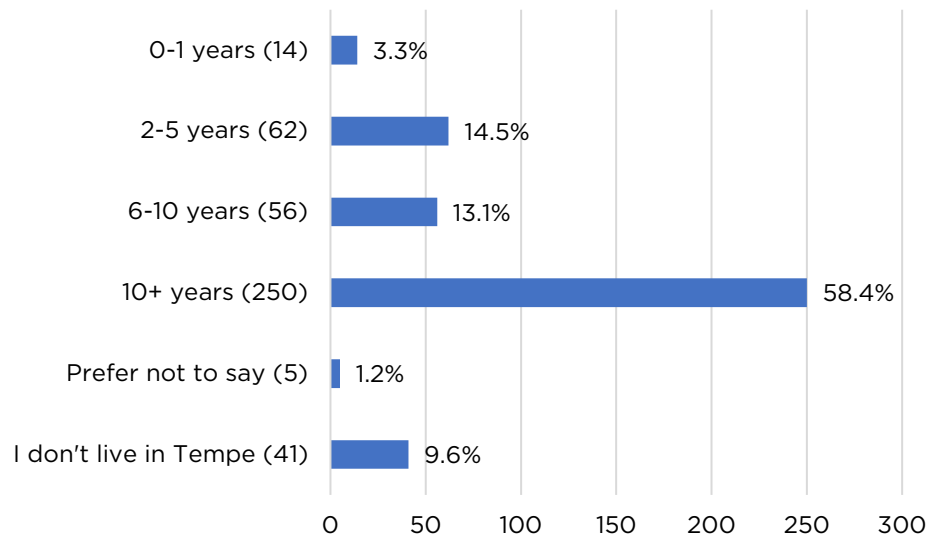

What is the primary language spoken at home?



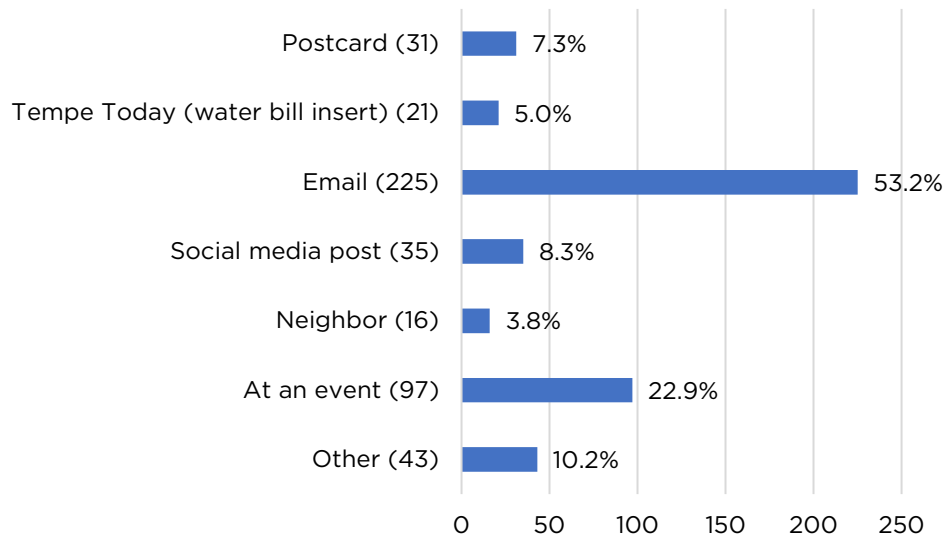

V. Emails

1. April 24, 2023 -

1. I have asked Maricopa County Supervisor Bill Gates to support Maricopa County Parks and Recreation Department joining the Act One Culture Pass program through the libraries. The program would make 10 county park passes available each week in libraries across the region. Currently, it is \$7 to enter the county parks using a vehicle pass (and the parks are mostly accessible only by car - not a single bus route exists). One thing we had mentioned during the planning process was the importance of having epic outdoor adventures within a 1.5 hour drive of the metro region. This is so those who are not able to pay to stay overnight can still have access to incredible outdoor recreation opportunities. It would be great to have Tempe's support in the initiative to get not only Maricopa County Parks, but also Tonto National Forest, to join the culture pass program so Tempe residents have more of an opportunity to have outdoor recreation experiences. (I raised \$460 by crowdfunding online and was able to purchase over fifty Tonto National Forest passes for the 5th grade students in Tempe! My hope is in the future they could check out a pass from their library and that anyone could visit the county parks and national forest.)

2. The river corridors and streetscapes have a huge opportunity to expand parks, trails, open space and recreational opportunities in the Tempe area by bringing park elements outside of park boundaries. The Center for the Future of Arizona 2020 Gallup Survey stated that, "75% of Arizonans think it's important "to reduce the heat island in our urban areas by planting trees and creating cooler outdoor walkways" These areas provide more opportunity for physical activity and a way to expand art throughout the city. With the Infrastructure and Investment Jobs Act (IIJA) it sounds like there will be a lot of transportation funding so we should build in trees, wide pathways, exercise equipment, and shade into the project where possible. Biking is the #1 outdoor activity nationwide for youth. For adults, it is still in the top 3, with walking and hiking come in ahead. Since biking is such a popular outdoor activity for youth and adults, we need to consider more safe biking opportunities in our communities, especially since according to the MAG Active Transportation Plan 1/3 of the region is obese or overweight.

3. It would be great if you all could get the full results of the Maricopa County Parks Vision 2030 Public Outreach Feedback Form to give you an idea of the responses we received across the county. For example, for how we could improve the visitor experience #1 was quality web-based park maps, #2 was helping low-income/underserved groups, #3 was improving ADA accessibility.

4. It would be great to have a website of wheelchair accessible viewing or park areas similar to Texas State Parks & Wildlife - https://tpwd.texas.gov/landwater/land/programs/tourism/wheelchair_access/ and I'm hoping AZ State Parks and Trails can do something similar. Currently, there is not a lot of ADA access at the Maricopa County Parks (one way I think

this can be improved is with adding paved or DG multi-use paths offset from the roads in the parks as currently as mostly they have just have dirt trails).

5. The Maricopa County parks survey received a strong response from the disc golf community. It seems to be one of the fastest growing newer sports, which may be something to consider making more available. On high-use trails in Colorado, hikers and bikers switch each day and the public enforces it. An employee of AZ State Parks and Trails (AZSPT) told me he went out to mountain bike and people told him it's a hiking-only day. I wonder if the golf courses could get more use by sometimes being available for disc golf.

6. I attached some data from the AZSPT Statewide Comprehensive Outdoor Recreation Plan (SCORP). I found these results interesting as it is showing a preference for more natural elements in parks and support for expanded pathways. This is so important as traditionally parks departments have focused within park boundaries, but the public is stating their support for pathways which are a win-win for recreation and transportation connectivity (and an opportunity to use IIJA funding!)
