SHEET TITLE **PHASE III BUILDING TYPE I FLOOR PLANS**



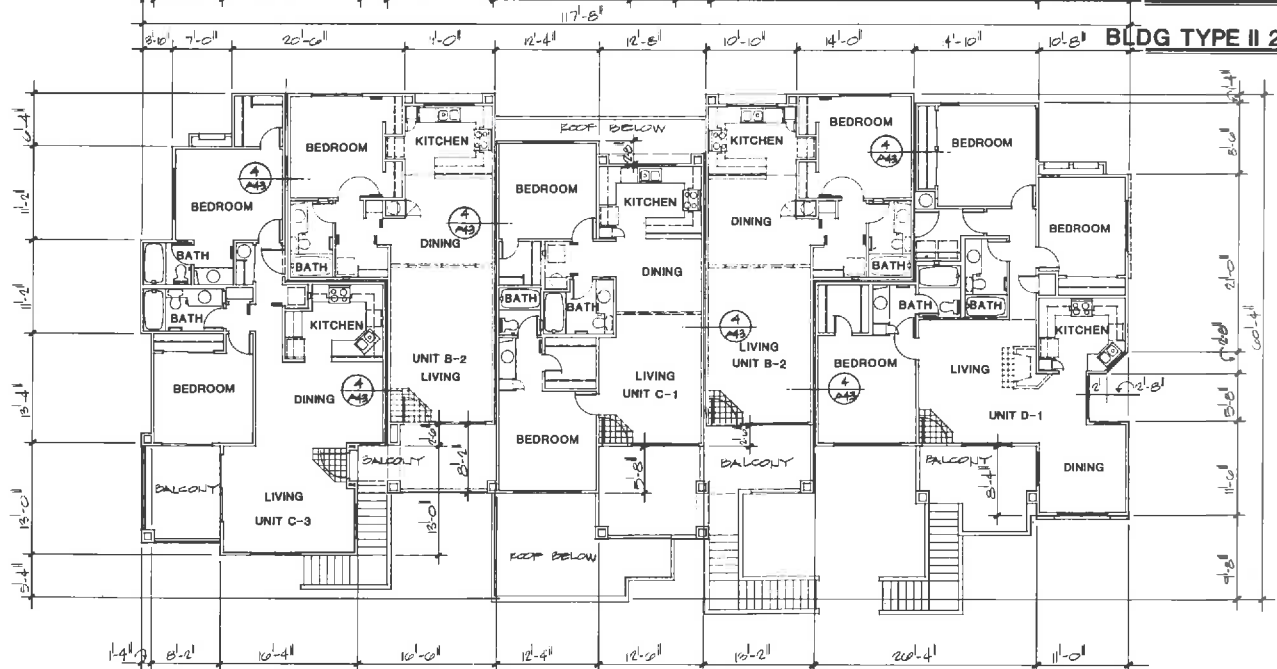

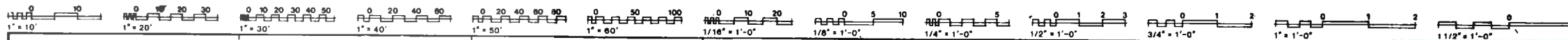

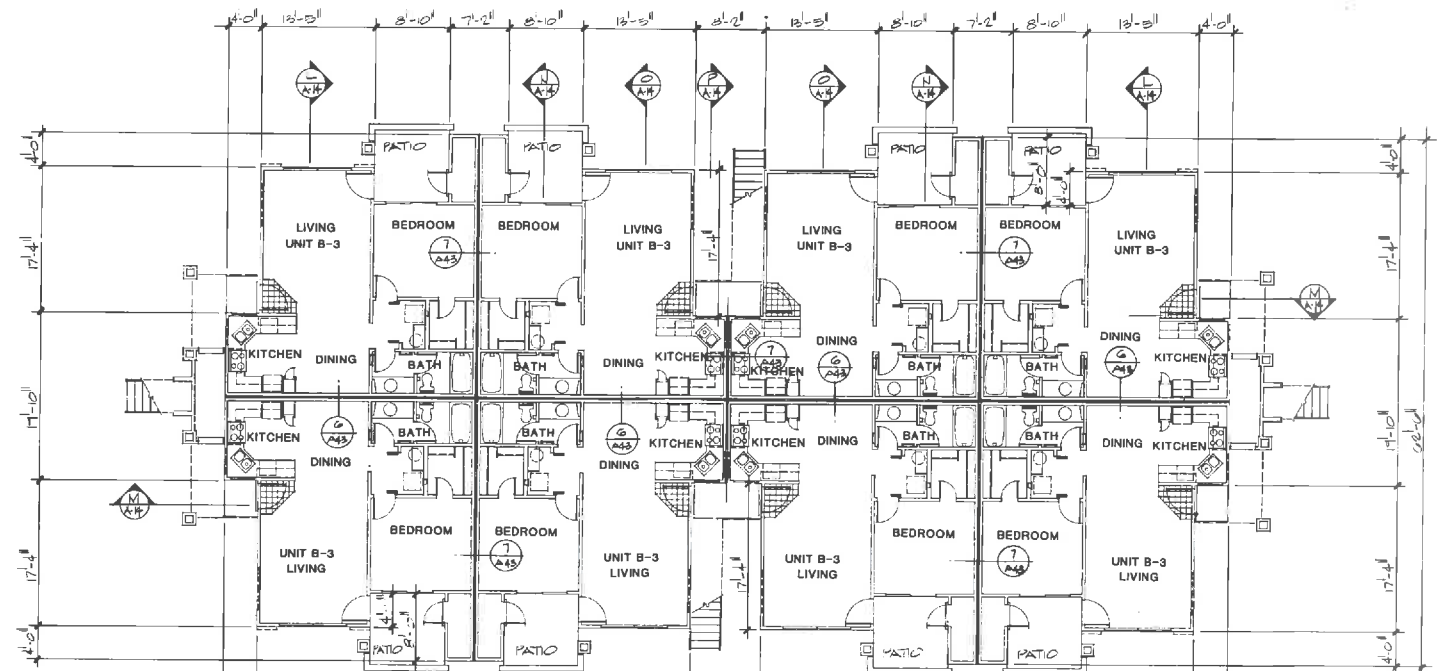

SHEET TITLE **PHASE III BUILDING TYPE II FLOOR PLANS**



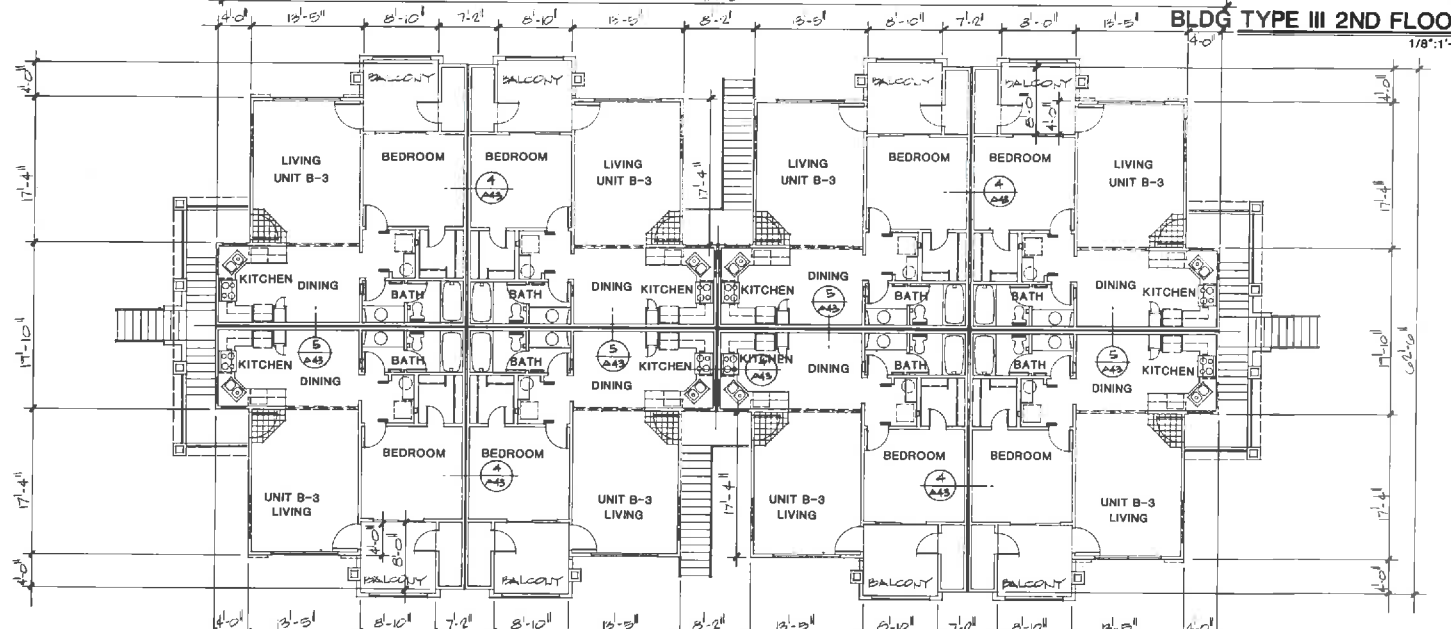
